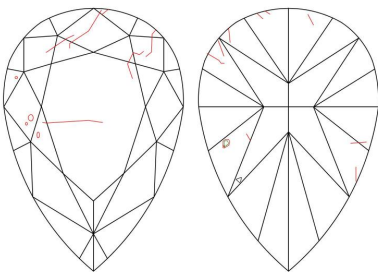

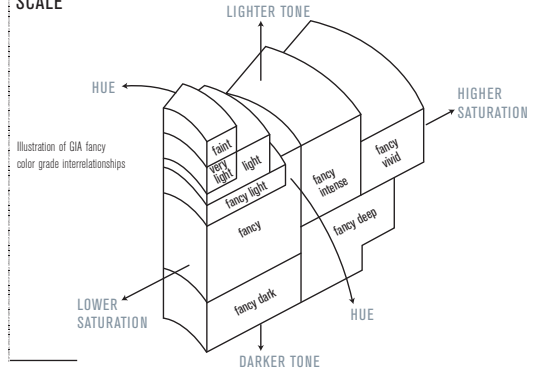

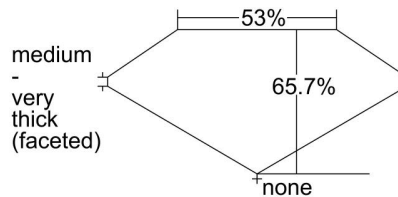

GIA COLORED DIAMOND SCALE



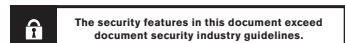
